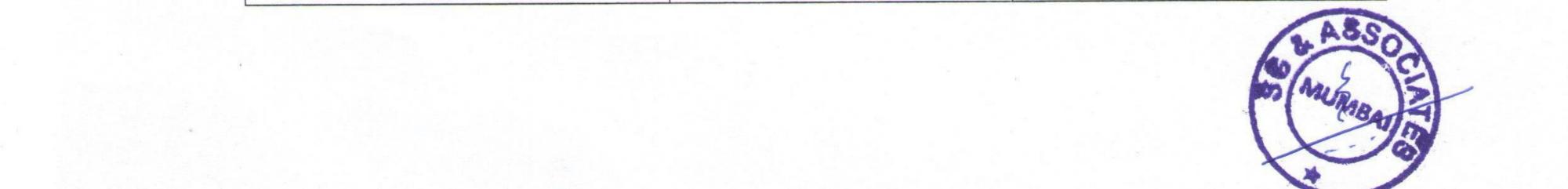

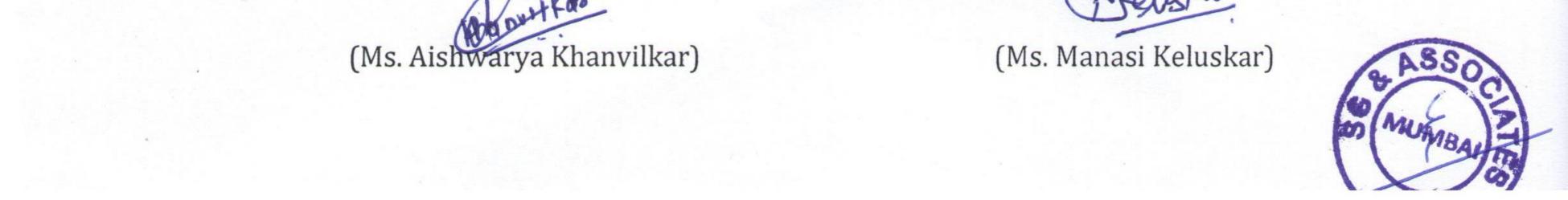
### **Report of Scrutinizer**

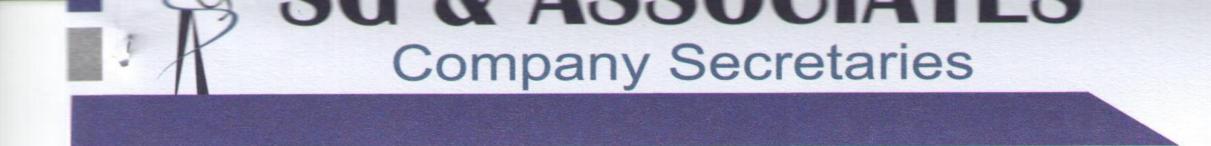

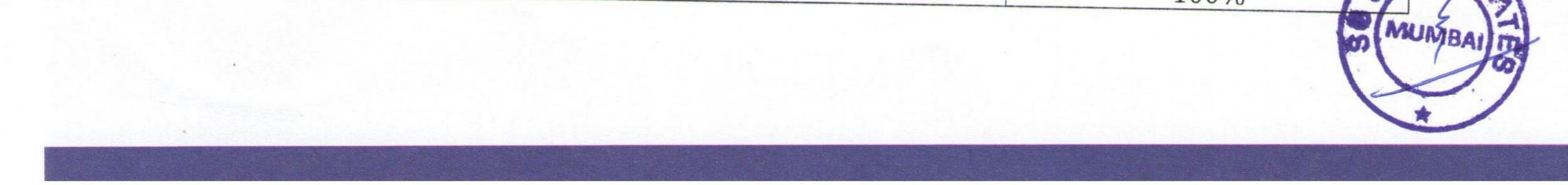
