We would like to inform the prestigious exchange that pursuant to Regulation 15(2) of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, the compliance with the Corporate Governance provisions as specified in regulations 17, 18, 19, 20, 21, 22, 23, 24, 25, 26, 27 and clauses (b) to (i) of sub-regulation (2) of regulation 46 and Para C, D and E of Schedule V **shall not apply in respect of the listed entity having paid-up Equity Share Capital not exceeding rupees Ten Crores and Net Worth not exceeding rupees Twenty Five Crores as on the last day of the previous financial year.**

In this regards, further, we would like to inform the exchange that the Paid-up Capital and Net Worth of the Company as per last audited Balance Sheet for the financial year ended *31st March 2019 is Rs.5,01,54,000/- (Five Crores One Lakh Fifty-Four Thousand) and Rs. 30,48,66,000/- (Thirty Crores Forty-Eight Lakh Sixty-Six Thousand) respectively.

The Authorized Share Capital and the Paid Up Capital of the Company as on 31st March 2020 is Rs. 6,00,00,000/- (Six Crores) and Rs.5,01,54,000/- (Five Crores One Lakh Fifty Four Thousand) respectively.


*** The company is in the process of finalizing financials for the year ended 31st March 2020. Hence, we are submitting the details based on 31st March 2019.**
